"WHITENING FOR LIFE" PROGRAM

We pride ourselves on the smiles that leave our practice. We also pride ourselves in knowing our patients are maintaining the best possible oral health. We invite you to participate in Bauer & Nemcik's "Whitening for Life" program, developed for those patients who are already taking their dental health seriously, and as an incentive for those who need a little help keeping up with their dental care. For a discounted fee of \$99.00, the patient will receive the Opalescence tooth whitening system including custom made, professional, take-home whitening trays and whitening gel for personal use. Thereafter, at every regular hygiene visit the patient will receive another six month supply of teeth whitening gel at no cost. This will also apply to patients who have already received whitening services at our office.

This "Whitening for Life" extended privilege, while absolutely free, does require some rules. Below is a brief description of the rules for this program. Please read them carefully, then review the policy and sign below, acknowledging receipt and understanding of compliance of said policy. While "Whitening for Life" is a gift from us to you, we insist that all rules are followed in order to receive this benefit.

Patient Activation Rules:

1. Must be at least 18 years of age.
2. Must complete initial hygiene cleaning, x-rays, doctor's exam, and re-appoint for six month re-care.
3. Must comply with minimum required dental care as treatment planned by doctor.
4. After all necessary dental treatment has been completed, patient will have impressions taken for professional whitening system and trays will be made and delivered.
5. Must complete all scheduled appointments. Cancellations will be made with a minimum 48 hour notice and original appointment rescheduled within the next 2 weeks.
6. Must not have any outstanding bills with Bauer & Nemcik Family Dentists, Inc.

Lifetime Maintenance Rules:

1. Must maintain minimum continued care as treatment planned and appointed by Bauer & Nemcik, its doctors, and staff.
2. Must maintain continued hygiene care (six month hygiene appointments, scheduled in advance).
3. Must comply with all Bauer & Nemcik policies regarding payment and broken appointments.
4. A maximum of three Opalescence tooth whitening solution refills will be rewarded at each re-care appointment.
5. Lost or destroyed applicator trays will be replaced at cost to patient (\$30.00).
6. Should any of the rules fail to be met, you will immediately be disqualified from the program and provided the opportunity to re-enroll for a \$30.00 re-activation fee.
